The first tournament discussed was the Meadowbrook tournament which is scheduled for May 26th:

- The tournament would need to use tee times vs. shot gun start, this is okay with Meadowbrook.
- Each player needs to have their own cart per state regulation. Meadowbrook was called to see if they had enough carts (4 carts/tee time) to provide 1 cart/player and they are going to email Trudy Dufault on Tuesday May 12 with an answer. Trudy will text Pat Dickson with the courses response and will forward the email to Pat.
- Tee times will be in accordance with state of RI guidance at 10 minute intervals.
- No food will be offered as part of the tournament and a price restructuring for the tournament will be implemented.
- Wendy Ossman may poll the membership to see who is interested in playing the Meadowbrook tournament. She will also put out a notice that registration is closed pending further notification from Meadowbrook.
- Only RI residents or people who have come to RI and have quarantined for 14 days are eligible to play in the Meadowbrook tournament.
- A vote to cancel the Meadowbrook tournament was taken with 3 members voting to cancel and 3 members voting to wait for additional information from Meadowbrook. 2 members who each get a 1/2 vote and canceled each other out.

The tournament at Raceway in CT is scheduled for June 1st and the OSWGA Board of Directors will meet next week to discuss this tournament
