- III. Treasurer's Report: Barbara Sitter
 - 1. Profit/Loss Comparison Year to Date June 2023 and Balance Sheet as of July 1, 2023, was email to the EBoard for review.
 - 2. Tournament Financials presented: River Ridge, Agawum, North Kingstown, Cranston, Pinecrest, and Segregansett. On hold: Raceway, and Back Nine until credit card statements are received.
 - 3. Re: Raceway, there were participants that were undercharged \$10 due to an incorrect fee posting on the initial registration. Those people were notified, and the additional fees were collected on the day of the event. Some paid cash others by check payable

to OSWGA. These funds were mailed to Barbara Sitter, Treasurer, however the mailing never reached her. Barbara notified the US postal service in her neighborhood as did Pat Doherty (mailer) to attempt to track down the missing mailing. Barbara drafted a note to be sent to all parties involved in the check/cash transaction to let them know to keep an eye out if their check was cashed.

IV. Tournament Directors' Report: Trudy Dufault

- 1. Tournament Co-Chair Lauretta Girouard reminded the board that a 50/50 drawing will be held once a month for members. It was decided that Green Valley CC would be the first setting for a drawing. A message will be sent out to membership as a reminder of this event. Tickets will be \$5 each and members may purchase as many chances as they like.
- 2. Tournament Director Trudy Dufault stated that the tournament schedule needs to remain as she presented it for posting on the website. i. e. Pairing request will be taken, or Pairing requests cannot be taking. It is important especially during medal play events that groupings are made based on handicap and not by who you want to play with.
 - 3. The RI Cup (OSWGA v LPGA-RI) teams have been posted on the website. It was noted that although some team members have returned to play from last year, new participants were rotated into the tournament.
 - 4. Carolyn Maney asked that tee number signs not be picked up before all teams have finished their round. Beth Penkala apologized in that she picked up the last sign her team played not realizing there was a B team playing behind them.
 - 5. Re: Annual Memorial Tournament in which one of the winning teams selected randomly gets to name a charity. Since the OSWGA is no longer filling the field as in the past, Trudy suggested that the donation amount be voted upon annually based on fees that are available from the designated memorial tournament.
